### **Brazil- China Innovation Dialogue 2017 November 28-29th Pal  cio do Itamaraty – Rio de Janeiro**

The annual Brazil China Innovation Dialogue, a joint initiative of the Institute for Brazil-China Studies and the Alexandre Gusm  o Foundation, is an occasion to discuss trends and challenges to innovation and investment policies in Brazil and China with a particular emphasis on responses to global challenges. It purports to create the basis for a continuous exchange among policy makers, researchers and firms interested in the drivers and processes to foster investments and innovation in Brazil and China.

The 2017 edition of the Dialogue will promote a discussion on how changes in the dynamics of international relations and economics of production are reshaping the multilateral agenda and affecting how we conceive nationally and globally strategies for investment, finance and innovation.

The Dialogues are organized with keynote addresses on each theme followed by a round table discussion amongst stakeholders. The concluding session points to issues which merit continuous policy focus.
